

CITY OF JESUP
ALL-TERRAIN VEHICLE AND OFF-ROAD UTILITY VEHICLE
REGULATIONS

OPERATION PERMITTED. All-Terrain Vehicles and Off-Road Utility Vehicles may be operated by person(s) in possession of a valid Iowa driver's license and at least 16 years of age. 16 and 17-year-old person(s) must carry a state certificate of course completion from the Department of Natural Resources.

STREETS. All-Terrain Vehicles and Off-Road Utility Vehicles shall be allowed to operate on all streets within city limits of the City of Jesup.

EQUIPMENT. All-Terrain Vehicles and Utility Vehicles shall be equipped with adequate brakes, muffler, mirror, headlights and brake lights. Lights must be used during operation.

HOURS. All-Terrain Vehicles and Off-Road Utility Vehicles may be operated only between sunrise and sunset. ATV's and UTV's may be operated during prohibited hours from 5:30 a.m. to 9:30 p.m. to perform snow removal activities, including removal of snow from sidewalks. Shall have the same equipment as required in section 75.09.

TRAFFIC LAWS APPLICABLE. While being operated on city streets, All-Terrain Vehicles and Off-Road Utility Vehicles are deemed to be motor vehicles and are subject to all provisions relating to the operation of motor vehicles.

LIABILITY INSURANCE. No person shall operate an All-Terrain Vehicle or Off-Road Utility Vehicle on city streets or alleys unless they are carrying a valid owner's policy of liability insurance.

REGISTRATION. All All-Terrain Vehicles and Off-Road Utility Vehicles that operate off the designated trail need to be registered with the City and display current registration stickers. Registration is annual with registration year extending from January 1 through December 31. There will not be refunds or prorated registrations. Registrations are non-transferrable.

RENEWAL. After initial registration, renewal stickers will be issued upon payment of the renewal fee. The sticker that is issued at Registration is a permanent sticker. **DO NOT REMOVE INITIAL STICKER.** The renewal stickers will be smaller stickers that will be placed on the original registration sticker.

SOLD ALL-TERRAIN VEHICLES AND OFF-ROAD UTILITY VEHICLES. If an All-Terrain Vehicle or an Off-Road Utility Vehicle is sold, the registered owner shall notify the City Clerk's office and request a cancellation of the registration of the All-Terrain Vehicle or Off-Road Utility Vehicle. Any existing registration for an All-Terrain Vehicle or Off-Road Utility Vehicle shall be deemed cancelled upon its sale. If the new owner intends to operate the All-Terrain Vehicle or Off-Road Utility Vehicle off the designated trail, the new owner shall register the All-Terrain Vehicle or Off-Road Utility Vehicle and pay the registration fee.

REVOKE REGISTRATION. The Chief of Police may revoke the registration of any All-Terrain Vehicle or Off-Road Utility Vehicle in the event of repeated violations, following a notice and an opportunity for a hearing.

RESPECT PUBLIC PROPERTY. All-Terrain Vehicles and Off-Road Utility Vehicles are considered motor vehicles are not to be driven in the parks, playground, on the sidewalks or through the grass. All-Terrain Vehicles and Off-Road Utility Vehicles shall not be operated on an operating railroad right-of-way. They may be driven directly across a railroad right-of-way only at an established crossing. They should be parked on the street or in a parking lot.
