Public Works Director Michael Fettkether spoke regarding the Hopkins and Prospect Street Improvements Project. This is an engineer's preliminary opinion of probable cost. This project would reconstruct Prospect Street from 6th Street to Hopkins Street and then Hopkins Street to Ainsworth and then Ainsworth to 4th Street with new water main, sewer main, curb and gutter, and asphalt street. This project would be completed in the summer of 2026. The council discussed expediting this project to be completed in the summer of 2025. Motion by Rohlfsen, seconded by Wright, to obtain an engineering agreement from Fehr Graham. Motion carried 4:0.

City Attorney Heather Prendergast spoke regarding the two ordinances for penalties for violations. If the police write a citation under the city code and the violation could be subject to imprisonment, the municipality is required to repay defense costs for appointed counsel defending municipal ordinance violations. To avoid this repayment, the city would need to remove imprisonment as a possible punishment.
